I. LAWS & REGULATIONS UPDATE

EDUCATION

▶ Sub-Decree Nº 110 (RGC) of August 11, 2008 on The Promotion and Name Change of Kampot Vocational Training Centre to Kampot Institute of Polytechnic (K.I.P) (Ogs, Year 08, N⁰ 62, August 23, 2008):

The purpose of this Sub-Decree is to promote and change name of Kampot Vocational Training Centre to Kampot Institute of Polytechnic (K.I.P). The K.I.P is located in Muoy Usaphea village, Kampong Kandal commune, Kampong Bay district, Kampot province and is under the supervision of the Ministry of Labor and Vocational Training [MLVT]. The Institute offers a less-than-one-year certificate degree, one, two or three vocational and technical diploma degrees, two-year associate degree, and four-year bachelor degree. The K.I.P consists of ten Offices and Departments: (i) Office of Administration and Personnel; (ii) Office of Finance and Planning; (iii) Office of Training Education; (iv) Office of Occupational Research and Industrial Relation; (v) Department of Vehicle and Agricultural Machinery; (vi) Department of Electricity and Electronics; (vii) Department of Civil Construction; (viii) Department of Business Management; (ix) Department of Foreign Languages; and (x) Department of Production and Services.

In the future, the K.I.P may open other departments, branches or specialize in other areas by preparing formalities approved by the MLVT.

FINANCE

► Circular N° 003 (MEF) of July 8, 2008 on The Technical Procedures of Making the Provincial/Municipal Budget Plan 2009 (Ogs, Year 08, N⁰ 57, August 04, 2008):

According to Circular No. 05 dated June 17, 2008 of the Royal Government of Cambodia on the Preparation of the Draft Financial Law for 2009 and Prakas No. 203 dated March 18, 1999 of Ministry of Economy and Finance on the Order for Provincial/Municipal Budget, the Ministry of Economy and Finance would like to instruct technical procedures for making a Provincial/Municipal Budget Plan 2009. The Provincial/Municipal Budget Plan 2009 shall be made in accordance with the form and contents of budget as attached to this Circular.

► Sub-Decree N° 97 (RGC) of July 23, 2008 on The Organization and Functioning of the Security and Exchange Commission of Cambodia (Ogs, Year 08, N⁰ 59, August 12, 2008):

The purpose of this Sub-Decree is to regulate the organization and functioning of the Security and Exchange Commission of Cambodia, briefly named "SECC".

The Director General of the **SECC** shall have the full right to manage and enforce works stated in security laws and provisions. The Director General shall have the rank and privileges equal to Secretary of State. The Director General shall be assisted by some deputy Directors General if necessary.

The **SECC** has six Departments under its supervision. The six Departments are as follows:

- 1. Department of Administration and Finance;
- 2. Department of Research, Training, Development of Security Market and International Relations;
- 3. Department of Security Sale Publication Management;
- 4. Department of Security Market Control;
- 5. Department of Security Intermediary Control; and
- 6. Department of Legislation.

The roles and duties of each Department, Internal Audit Entities of the **SECC**, officials of the **SECC**, organization of the **SECC**, funding source and financial management, and final provisions are stipulated in detail in this Sub-Decree.

► Sub-Decree N° 102 (RGC) of June 29, 2008 on The Budget Credit Transfer (Ogs, Year 08, N⁰ 60, August 15, 2008):

According to a proposal by the Minister of Economy and Finance, the budget credit of 800,000,000 Riels (eight hundred millions) may be transferred from Chapter 09 (unplanned expenses) of unallocated expense items to Chapter 65 (subvention and social assistance) to the Council of Ministers for 2008. The allocation of the internal budget credit expenditure of these Chapters by accounts and sub-accounts shall be made by Prakas of the Minister of Economy and Finance for providing the money to the National Committee on Counter-Terrorism for the expenditure on administrative affairs until the end of 2008.

► Sub-Decree N° 107 (RGC) of August 1, 2008 on The Budget Credit Transfer (Ogs, Year 08, N⁰ 62, August 23, 2008):

According to a proposal by the Minister of Economy and Finance, the budget credit of 615,000,000 Riel (six hundred fifteen millions) may be transferred from Chapter 09 (unplanned expenses) of unallocated expense items to Chapter 65 (purchase) to the Constitutional Council for 2008. The allocation of the internal budget credit expenditure of these Chapters by accounts and subaccounts shall be made by Prakas of the Minister of Economy and Finance for advanced payment for buying two vehicles.

INSURANCE

► Prakas N° 608 (MEF) of August 12, 2008 on The Life Insurance Business (Ogs, Year 08, N° 61, August 19, 2008):

The Ministry of Economy and Finance, pursuant to its requirement, had decided to issue Prakas on the Life Insurance Business. The Prakas provides for general provisions, produce and transactions, finance and accounting, company treatment in the financial crisis, the transfer of life insurance business,

dissolution and liquidation of life insurance companies, the sale of life insurance cards, and offenses in the insurance business to which their details are stipulated in this Prakas.

▶ Prakas N° 549 (MEF) of July 30, 2008 on The Accounting Instruction Principles for General Insurance Business (Ogs, Year 08, N⁰ 59, August 12, 2008):

The Ministry of Economy and Finance, pursuant to its necessity, has decided to put the accounting instruction principles for general insurance companies and reinsurance companies in Cambodia into operation. The principles are found in this present Prakas, and Prakas No. 198 dated April 04, 2005 on the Accounting Instruction Principles are abrogated.

LAND & PROPERTY

▶ Prakas N° 548 (MEF) of July 30, 2008 on The Management, Control, and Granting of License to Real Estate Development Legal Entity or Natural Person (Ogs, Year 08, N⁰ 58, August 08, 2008):

The purpose of this Prakas is to establish a mechanism for managing, controlling and granting a license to real estate developers doing their business or who will do their business, as well as establish rules for management of real estate development in the Kingdom of Cambodia. This Prakas also aims at the regulation of the following provisions:

- To improve and direct all real estate developers who are doing their business in the Kingdom of Cambodia;
- To push for confident and acceptable real estate development through the control of real estate development business projects, financial project management, real estate development accounts, and audition of implementation of sale/purchase agreements;
- To increase the client's trust in real estate investment;
- To ensure national economic sustainability and real estate development in accordance with national and international standards:
- To prevent unauthorized and unclear real estate developments; and
- To increase the national income through tax and other fees.

The control and granting of licenses, inter provisions, and final provisions are stated in details in this Prakas.

► Sub-Decree N° 93 (RGC) of July 18, 2008 on The Transfer of State Permanent Reserve Forestland for Economic Land Concession in Traeng Trayeung Commune, Phnom Sruoch District, Kampong Speu Province and Ta Kaen Commune, Chhuk District, Kampot Province (Ogs, Year 08, N⁰ 59, August 12, 2008):

Under this Sub-Decree, 329-hectares of permanent reserve forestland in Traeng Trayeung Commune, Phnom Sruoch District, Kampong Speu Province and Ta Kaen Commune, Chhuk District, Kampot Province has been considered as

transferred land for other developments. The above forestland has been determined in attached master map which is an annex of this Sub-Decree and having code numbers of **A** (406750, 1229110); **B** (411350, 1229110); **C** (411350, 1228090); **D** (409800, 1228090); **E** (409800, 1228414); **F** (408537, 1228414); **G** (408537, 1228580); **H** (407100, 1228580); **I** (407100, 1228795); **J** (406950, 1228795); **K** (406950, 1229010); and **L** (406750, 1229010).

The above transferred forestland for other developments shall be broken up from State permanent reserve forestland. The 329-hectare forestland which is the State public property and is stated above shall be transferred to State private property by cutting 222-hectare economic concession land from FIRST BIOTECH [company] and 55-hectare economic concession land from RADASY [company].

The mandate for occupying the 329-hectare State private land shall be granted to the Ministry of Agriculture, Forestry and Fisheries (the Forest Administration) to provide economic land concession to poor people living in that locale in accordance with principles and norms determined by the Royal Government.

► Sub-Decree N° 99 (RGC) of July 29, 2008 on The Transfer of State Permanent Reserve Forestland and Granting Economic Land Concession to Private Company for Investing in Rubber Plantation in Kratie Province (Ogs, Year 08, N⁰ 60, August 15, 2008):

Under this Sub-Decree, 479-hectare (four hundred seventy nine) State permanent reserve forestland boundary (SL. International Ltd's concession forestland) in Pithnou commune, Snuol district, Kratie province has been classified as a transferred land for other developments. The land plan location has been determined in a master map attached to an annex of this Sub-Decree and its code numbers are stated in this Sub-Decree.

The transferred forestland for other developments as mentioned above shall be broken up from the State permanent reserve forestland boundary. The 479-hectare (four hundred seventy nine) land, the State public property, as stipulated above shall be transferred to State private property.

The mandate for the occupation of State private land shall be granted to the Ministry of Agriculture, Forestry and Fisheries to provide economic land concession to RATANAK STON (CAMBODIA) DEVELOPMENT in accordance with principles and norms determined by the Royal Government.

► Sub-Decree N° 100 (RGC) of July 29, 2008 on The Transfer of State Permanent Reserve Forestland and Granting Economic Land Concession to Private Company for Investing in Rubber Plantation in Kratie Province (Ogs, Year 08, N⁰ 60, August 15, 2008):

Under this Sub-Decree, 520-hectare (five hundred twenty) State permanent reserve forestland boundary (SL. International Ltd's concession forestland) in Pithnou commune, Snuol district, Kratie province has been classified as a transferred land for other developments. The land plan location has been determined in a master map attached to an annex of this Sub-Decree and its code numbers are stated in this Sub-Decree.

The transferred forestland for other developments as mentioned above shall be broken up from State permanent reserve forestland boundary. The 520-hectare (five hundred twenty) land, the State public property, as stipulated above shall be transferred to State private property.

The mandate for the occupation of State private land shall be granted to the Ministry of Agriculture, Forestry and Fisheries to provide economic land concession to THE INVESTMENT [company] as defined by principles and norms of the Royal Government.

► Sub-Decree N° 101 (RGC) of July 29, 2008 on The Transfer of State Permanent Reserve Forestland and Granting Economic Land Concession to Private Company for Investing Rubber Plantation in Kratie Province (Ogs, Year 08, N⁰ 60, August 15, 2008):

Under this Sub-Decree, 678-hectare (six hundred seventy eight) State permanent reserve forestland boundary (SL. International Ltd's concession forestland) in Pithnou commune, Snuol district, Kratie province has been classified as a transferred land for other developments. The land plan location has been determined in a master map attached to an annex of this Sub-Decree and its code numbers are stated in this Sub-Decree.

The transferred forestland for other developments as mentioned above shall be broken up from State permanent reserve forestland boundary. 678-hectare (six hundred seventy eight) land, the State public property, as stipulated above shall be transferred to State private property.

The mandate for the occupation of State private land shall be granted to the Ministry of Agriculture, Forestry and Fisheries to provide economic land concession to JPE Co., Ltd in accordance with principles and norms determined by the Royal Government.

▶ Sub-Decree N° 108 (RGC) of August 7, 2008 on The Transfer of Boeung Kok Locations from State Public Property to State Private Property (Ogs, Year 08, N⁰ 60, August 15, 2008):

Under this Sub-Decree, 132.31-hectare (one hundred thirty two hectare and thirty one) Boeung Kok lake in Srah Chak quarter, Daun Penh district, Phnom Penh has been transferred from State public property to State private property for developments whose code numbers are stated in this Sub-Decree.

► Sub-Decree N° 109 (RGC) of August 8, 2008 on The Determination of Kangna Reservoir Surface in Kampong Svay Commune, Serei Sophorn District, Banteay Meanchey Province as State Public Property (Ogs, Year 08, N⁰ 62, August 23, 2008):

Under this Sub-Decree, 51-hectare Kangna reservoir surface in Kampong Svay commune, Serei Sophorn district, Banteay Meanchey Province has been determined as State public property (in accordance with Geographical Position System, GPS DATUM: INDIAN-THAILAND 1960).

► Announcement N° 021 (MEF) of August 19, 2008 [on The Real Estate Development License] (Ogs, Year 08, N⁰ 62, August 23, 2008):

The Ministry of Economy and Finance [MEF] would like to inform all natural persons and legal entities developing real estate that physical persons and legal persons doing business on real estate development (construction of residences, flats, or condominiums, or division of plot of lands for sale or rent) shall apply for a real estate development license from the MEF.

If one does not have a license from the MEF, the person shall be fined under the 2007 Financial Law.

The MEF shall take strict action against any natural person and legal entity doing a business on real estate development (construction of residences, flats, or condominiums, or division of plot of lands for sale or rent) and failing to apply for real estate development license no later than September 30, 2008.

➤ Sub-Decree N° 120 (RGC) of August 22, 2008 on The Transfer of State Permanent Reserve Forestland for Economic Land Concession to Invalid Soldiers' Families in Srae Kor and Ta Lat Communes, Sesan District, Stung Treng Province (Ogs, Year 08, N° 64, August 31, 2008):

Under this Sub-Decree, 594-hectare permanent reserve forestland in Srae Kor and Ta Lat Communes, Sesan District, Stung Treng Province has been considered as transferred land for other developments. The above forestland has been determined by code numbers of **A** (652869, 1499872); **B** (659530, 1504978); **C** (659131, 1505545); and **D** (652476, 1500428).

The above transferred forestland for other developments shall be broken up from State permanent reserve forestland. The 329-hectare forestland which is the State public property and is stated above shall be transferred to State private property by cutting 419-hectare economic concession land from PHO MADY INVESTMENT GROUP, 164-hectare economic concession land from SIV

GATE INVESTMENT GROUP, and 11-hectare economic concession land from permanent forestland.

The mandate for occupying the 594-hectare State private land as stated above shall be granted to the Ministry of Agriculture, Forestry and Fisheries (the Forest Administration) to provide a economic land concession to families of soldiers in accordance with the requirements and principles determined by the Royal Government.

LEGAL PROFESSION

▶ Sub-Decree N° 116 (RGC) of August 18, 2008 on The Establishment of Royal School of Bailiff of the Royal Academy for Judicial Profession [RAJP] (Ogs, Year 08, N⁰ 63, August 27, 2008):

Under this Sub-Decree, the **Royal School of Bailiff** has been formed to be under the structure of direct management and leading of the Royal Academy for Judicial Profession [RAJP].

The Royal School of Bailiff shall have the following duties:

- To be in charge of training bailiffs in primary vocation and continuance of training them;
- To raise a working strategy and make an action plan for bailiff vocational training;
- To prepare pedagogic documents for bailiff vocational training;
- To prepare training programs for teachers to train bailiffs;
- To follow up and inspect the study and disciplinary respect of bailiff students;
- To inspect trainability of bailiff students;
- To prepare an annual report on moral status and school development plan for the Chief of RAJP before submitting it to the board of directors of the RAJP; and
- To inspect and manage the works of Sub-Units.

The training of bailiffs shall be under the management of the RAJP by closely cooperating with the Ministry of Justice. The structure; bailiff student recruitment and exam, and training; funding source; and final provisions are stated in details in this Sub-Decree.

▶ Sub-Decree N° 117 (RGC) of August 18, 2008 on The Establishment of Royal School of Notary of the Royal Academy for Judicial Profession [RAJP] (Ogs, Year 08, N⁰ 63, August 27, 2008):

Under this Sub-Decree, the **Royal School of Notary** has been formed to be under the structure of direct management and leading of the Royal Academy for Judicial Profession [RAJP].

The Royal School of Notary shall have the following duties:

- To be in charge of training notaries in primary vocation and continuance of training them;
- To raise a working strategy and make an action plan for notary vocational training;
- To prepare pedagogic documents for notary vocational training;
- To prepare training programs for teachers to train notaries;
- To follow up and inspect the study and disciplinary respect of notary students;
- To inspect trainability of notary students;
- To prepare an annual report on moral status and school development plan for the Chief of RAJP before submitting it to the board of directors of the RAJP; and
- To inspect and manage the works of Sub-Units.

The training of notaries shall be under the management of the RAJP by closely cooperating with the Ministry of Justice. The structure; notary student recruitment and exam, and training; funding source; and final provisions are stated in details in this Sub-Decree.

PUBLIC ADMINISTRATION

▶ Prakas N° 078/08 (MNASRI) of June 20, 2008 on The Code of Ethics of Inspection Civil Servants of the Ministry of National Assembly-Senate Relationship and Inspection (Ogs, Year 08, N⁰ 58, August 08, 2008):

This Prakas aims at regulation of the code of conduct of inspection civil servants of the Ministry of National Assembly-Senate Relationship and Inspection. The scope of this Prakas covers inspection civil servants of the Ministry of National Assembly-Senate Relationship and Inspection which is responsible for inspecting all kinds of woks to increase the effectiveness of good governance.

The adherence of good discipline and attitude for the implementation of works is based on fundamental principles which are criterions of inspection profession. The principles are the guide of leading inspection forward to their professional responsibilities and are the code of ethics for fulfilment of obligations of inspection civil servants. The fundamental principles include honest, impartial, professional ability, professional level, professional attitude, independence, benefit dispute, obligations in work performance, obligations in and out of working hour, and obligations out of working hour.

Procedures for punishment of inspection civil servants are complied with Law on Co-Statute of Civil Servants or Sub-Decree No. 10 dated January 28, 1997 on the Procedures for Implementation of Discipline on Civil Servants.

TAXATION

▶ Prakas N° 547 (MEF) of July 30, 2007 on The Collection of Tax on Transport Means and Vehicles of All Types for 2008 (Ogs, Year 08, N⁰ 58, August 08, 2008):

The main purpose of this Prakas is to inform and invite all owners of transport means and vehicles of all types to pay tax on transport means and vehicles. The collection of tax on the transport means and vehicles of all types will be started from August 15, 2008 to November 15, 2008.

Any vehicle, whose owner failed to pay tax on transport means and vehicles of all types for 2007 and sold it to other parties, shall pay tax for 2007 as well as get fined under the Cambodian laws before the tax payment for 2008 is allowed. From November 16, 2008 onwards, the Tax Units shall conduct inspections and impose a fine in the amount equal to the tax fee to be paid for transport means and vehicles on any owner failing to pay tax for 2008. Any transport means and

vehicles of all types which have been put into circulation after November 15, 2008 shall be certified by receipts or other documents by sellers together with a letter of tax declaration. A fine in the mount equal to tax fee to be paid for 2008 shall be imposed in case for the tax declaration is not made within one month from the circulation date.

The List of tax fees determined for transport means and vehicles of all types is provided and attached to this present Prakas.
