I. LAWS & REGULATIONS UPDATE

BANKING

▶ Prakas N°7.09-074 (NBC) of February 25, 2009 on the Asset Classification and Provisioning Banking and Financial Institution (Ogs, Year 09, N° 22, March 23, 2009):

This Prakas has the objectives to assure that all credits and assets of all banks and financial institutions, called "Institutions", are carefully valued by the classifying system, and that the provision can be duly registered in an account or deleted from the registry for disappearing provision, in order to reflect the real operation of the institutions.

Furthermore, it is applicable to all credits, such as anticipated credits, similar assets, including all credits granted to the branches and relative offices contained in the list of balance of the institutions. The Prakas also clarifies the flow of interest, process of collection of interest, credit and anticipated credit, circulating assets, non-circulating assets, expense of lost provision, provision for lost credit, preparing credit...etc.

On the other hand, this Prakas classifies credits and assets into many kinds, based on the possibility to pay back by a borrower, and it prevails how to appreciate the possibility of a borrower to pay back with the description of the kinds of credits and assets. In addition, it shows the ways and rights of cancelation of credit, anticipated credit, as well as the control or examination of the credit by the institutions (banks, financial institutions).

► Prakas N°7.09-075 (NBC) of February 25, 2009 on the Minimum-Obligatory Deposit Funds of the Bank and Financial Institution (Ogs, Year 09, N° 23, March 27, 2009):

This Prakas aims to set a goal in ordering the banks and financial institutions, called "Institutions", to place the minimum obligatory deposit at the NBC. Therefore, the institutions shall sufficiently place the minimum reserved obligatory deposit during the deposit period in the NBC, in order to easily, safely, and strictly assure the management of liquidity operation.

This minimum obligatory deposit is either the instrument of performance of currency policy or the obligation for controlling the institutions. But, it may be changed according to the performance of the currency policy as well as the universal economic opportunity/situation. The deposit shall be an asset and shall be placed for the duration of 14 consecutive calendar days which is the minimum number of days for the deposit duration. In the case of deficit of the minimum obligatory deposit by insufficiency of deposit or placing or other acts prescribed in the Prakas, fines can be imposed on the institutions.

CUSTOMS & IMPORT EXPORT

► Prakas N° 211 (MEF) of February 27, 2009 on the Establishment and Functioning of the Management Unit for the Imported Goods Transited fees (Ogs, Year 09, N° 17, March 04, 2009):

This Prakas has the purpose to create the management unit of the imported transited goods fees subordinate to the Cambodian General Department of

Customs and Excises led by the customs and excise officials. This unit is divided into three groups that have the competency to work with a number of customs and excise officials, so as to manage the change to the imported transited goods fees with respect to the list of Cambodian customs tax in effect. Each group of work routinely searches the price and evolution of the fees of imported transited goods, based on the various databases of previous fees and precedent custom fees on commodity. This Prakas also enumerates the roles and duties of the unit, the work groups (team) of the unit, such as research management and making a proposal of public policy on custom fees in accordance with the provisions in force.

EDUCATION

▶ Royal Decree Nº NS/0309/243 of March 02, 2009 on the Amendment to Articles 13, and 30 of the Royal Decree on the Tertiary Accreditation and the Amendment to the New Article 11of the Royal Decree on the Amendment to the Article 10, 11, 14, 15 and 16 of the Royal Decree on the Tertiary Accreditation. (Ogs, Year 09, N⁰ 20, March 15, 2009):

The new article 13 states the members of quality recognized education committee of Cambodia has three mandates and can be re-appointed by appointment or voting in accordance with the procedures stipulated by Royal Decree N° NS/0205/097, dated February 22, 2005, on the amendment to articles 10-11 and 14-16 of Royal Decree Regarding the Quality Recognition of Higher Education and new Article 30 stipulated that the foundation year shall study four subjects there are:

- Art and humanity;
- Mathematics, science, and information technology;
- Social science;
- Foreign languages.

The credit of each subject shall be at least 10 percent of total credit for this foundation year.

FINANCE

▶ Prakas N° 219 (MEF) of March 05, 2009 on the Establishment of the Sub-Committee for Capacity Building to the Officials for Implementing Program of the Public Financial Management Reform. (Ogs, Year 09, N° 18, March 08, 2009):

This Prakas aims to create a Sub-Committee for building the capacity of officials, and implementing the public financial management reform in the Ministry of Economy and Finance by listing the composition of the Sub-Committee. It additionally describes the Sub-Committee's roles and duties, such as: acting as presidency of the committee of public financial management reform and the MEF for implementing plan, program and training courses to build the capacity of officials, monitoring and recommending the capacity building of officials in order to implement the public financial management reform in cooperation with Ministries, Institutions of the Royal Government.

After completing these roles and duties, the Sub-Committee files and submits a report to the Committee of public financial management reform and the leaders of Ministries on the processes of capacity building of officials in the implementation of public financial management reform, in order to examine and make a decision.

LAND & PROPERTIES

▶ Sub-Decree N⁰ 47 (RGC) of March 23, 2009 on the Creation of the Forest Protection Zone for Recreation and Hunting Sport Oyadav, Ratanakiri Province. (Ogs, Year 09, N⁰ 24, March 31, 2009)

Under this Sub-Decree, 101348 hectares of land created the forest protecting zone for recreation and hunting sport in Oyadav District, Ratanakiri Province.

This Sub-Decree aims at the following provisions:

- Recreation and tourism in Kingdom of Cambodia;
- To protect and conserve natural resources and ecology zone included genetic resources, plants, and wild animals that are being accident and extinguished;
- Preserve natural environmental for shelter and animals reproduction;
- Develop hunting sport at international level;
- Create research center for forestry ecology, wild animals and variety of plants in ecology zone;
- Unite in poverty deduction in community through providing work opportunity in tourism sector and ensure ecology perpetuity, social economic, and living standard.

The Ministry of Agriculture, Forestry and Fisheries has authority to organize and manage Forest Protecting Zone for Recreation and Hunting Sport in Oyadav District, Ratanakiri Province in corporate with concerned Ministries to insure development of natural resource perpetuity.

The formalities and procedures to implement this Sub-Decree and others provisions concerning hunting season, location, amount, time, and kind of wild animals allows for hunting shall determine in Prakas of Minister of the Ministry of Agriculture, Forestry and Fisheries.

Methodology and instruments use for hunting shall determine in joint Prakas of the Ministry of Agriculture, Forestry and Fisheries and Ministry of Interior.

PUBLIC ADMINISTRATION

► Sub-Decree N° 44 (RGC) of March 03, 2009 on the Organization and Functioning of the Secretariat General of the Council for Economy, Social and Culture (OBSES) (Ogs, Year 09, N° 17, March 04, 2009):

This Sub-Decree is to determine the organization and functioning of the Secretariat General of the Economic, Social and Cultural Council (OBSES) that is the secretariats of its daily work.

The Sub-Decree divided to as the four main chapters which included the General Provisions as mentioned in above paragraph, Roles and Function, Structure and Management and the Responsibilities of each sector in (OBSES).

- The Role and Function of OBSES is to assist on administrative work, organize meeting, set up training and capacity building to improve its members and other tasks assigned by chief of OBSES.
- Structure and Management of the General Secretariat (OBSES) led by one General Secretary and some deputy-General Secretary as necessary. The General Secretariat (OBSES) are structured as administration, staffs and protocol, financial and supplying, analysis the economic, social and cultural situation, studies, research and observation...., and communication and international cooperation as the last sector.
- Each sector (offices) led by one chief and one deputy-chief, each are response to complete its roles and functions as stipulated in the sub-decree.

► Sub-Decree N° 46 (RGC) of March 12, 2009 on the Justification the Department of Training and Retraining, Ministry of Interior (Ogs, Year 09, N° 19, March 12, 2009):

This Sub-Decree is to modify the "Training and Enhancing" which currently subordinate to Secretariat General of National Police to the "Training Department subordinate to National Polices Academy" of the Ministry of Interior.

The Training Department of Cambodia Police Academy has the obligations to raise the goals and building up the plan for training and pedagogy at all the subordinate departments, arranging and implementing training plan, research and setting up documentations, teaching, inspection, and other tasks assigned by the Department Chief of Cambodia Police Academy and Minister of Interior.

The department should be led by its one chief of department and its one deputychief as assistant. The department has its expert offices and some national police schools as subordinators. Cambodia Police Academy should be in cooperation with National Police Secretariat General, which consists of Training department and personnel department as secretariats to build training plan to national police officers.

▶ Decision N° 19 (RGC) of March 16, 2009 on the Work Pattern and Job Description for the Royal Government Members. (Ogs, Year 09, N° 21, March 19, 2009):

The Sub-Decree is to make the classification of works and duties to Prime Minister, Deputy Prime Minister, and Senior Ministers, who are in charge of special missions to guarantee the implementation of the law and general works of state.

For Prime Minister: Samdech Akka Moha Sena Padei Techo Hun Sen is in charge of general works, joint-works of the council of minister, arrange and order every activities of the Royal Government of Cambodia of all fields, directly control on disaster, economics and finance and Council for the Development of Cambodia (CDC).

For Deputy-Prime Ministers: this Decision mentions and make the clear division of works to the 10 deputy prime ministers which include; H.E. SOR Kheng, H.E. SOK Ann, H.E. TEA Bagn, H.E. HOR Namhong, Her Excellency MEN Som Orn, H.E. BIN Chhin, H.E. NHIK Bunchai, H.E. KIET Chhon, H.E. YIM Chaily, and H.E. KEO Kimyarn. All the deputy prime ministers are in charge of separate roles and functions as stipulated in the Decision. The prime minister and deputy prime ministers are the permanent team in the Council of Ministers.

For the Senior Ministers for Special Missions: H.E. NHIM Vanda, H.E. TAV Seng Huor, H.E. KHUN Hang, H.E. LY Thuch, H.E. KUL Pheng, VENG Serivuth, H.E. SUN Chhan Thol, H.E. NUTH Sokhum, H.E. OMM Yinteang, H.E. EANG Muly, H.E. VAR Kimhong, H.E. YIMNol Lar, H.E. SEREI Kosal. All are in charge of roles and functions from the appointment of the Royal Government of Cambodia for their special missions. Senior ministers are also in charge of additional works delegated from the Prime Minister. All the senior ministers have four assistants, two of which has status equal to General Director and two equal to department's chief.

TAXATION

► Prakas N° 196 (MEF) of February 24, 2009 on the Remuneration Allocation From the Tax Examination on the All Transportation Means (Ogs, Year 09, N° 17, March 04, 2009)

In the annual control, all fines on tax of all types of the transportation and vehicle means, that were collected in cooperation of tax officials and competent officials may be allocated, in accordance with percentage of collected tax; 50% of the fines are given to the state budget; another 50% may be divided into various awards for relevant institutions, such as the tax department, provincial, municipal, district cashiers.

In addition, this Prakas authorizes provincial or district tax branches of Phnom Penh municipality to immediately take award from the fines on all types of transportation and vehicle means for each year for their members in accordance with fixed percentage.

► Prakas N° 212 (MEF) of February 27, 2009 on Tax Collection on the All Transportation Means (Ogs, Year 09, N° 17, March 04, 2009):

Tax on transportation means and all types of vehicles for 2009 shall be collected from April 01, 2009 to June 31, 2009. The tax shall be determined, in accordance with each type of vehicles without taking into consideration the public or private means in exclusion of some types of vehicles specifically mentioned, such as ambulance, fired engine, transportation means or vehicles of embassy, consulates, international organizations.

To collect this tax for 2009, the owners of all types of vehicles are required to complete two application forms approved by the tax department by presenting and submitting receipts of tax on all vehicles already paid for 2008 to the competent officials, except motorcycles. On the other hand, the owners, who do not have receipts of paid tax of 2008, shall pay tax of 2008 and fines for being authorized to pay tax for 2009.

However, if they lost the receipts of paid tax 2008, they shall have the attestation of paid tax 2008 issued by the director of provincial or district tax branches of Phnom Penh Municipality. After paying the tax, the owners shall obtain a receipt of tax payment and a tax stamp, so as to stick on the vehicle. Furthermore, this Prakas not only describes the kinds, features, colors of tax stamp, but also the date, which authorizes the control of the tax department on all transportation means and vehicles.
